



WASTE VEGETABLE OIL COLLECTION AGREEMENT

This Agreement is entered into as of _____, 2008 between the undersigned (“Customer”) and Blue Sky Bio-Fuels (Agent)

The parties agree:

1. Customer grants Blue Sky Bio-Fuels the exclusive right to collect, transport and process all of Customer’s waste vegetable oil (WVO) from the locations set forth below and Blue Sky Bio-Fuels agrees to provide such services to Customer (the “Services”).
2. Blue Sky Biofuels will provide the Services as needed, but at least monthly Blue Sky Bio-Fuels will give Customer drums in which to store WVO in advance of the first Service Date. Blue Sky Bio-Fuels will give Customer one week’s advance notice of the first Service Date. On each Service Date, Blue Sky Bio-Fuels will collect from Customer the drums containing WVO (and no other waste material) and will provide Customer with clean drums marked with the Blue Sky Bio-Fuels logo. If, due to the volume of WVO, Customer requests additional, non-scheduled Service, Blue Sky Bio-Fuels shall perform such service as soon as practicable.
3. Customer warrants that WVO collected by Blue Sky-Biofuels will not contain material amounts of water or food scrap, or any, flammable, explosive, toxic or hazardous material.
- 4 Customer will provide unobstructed access to the drums on the scheduled Service Date.
5. This Agreement is for an initial term of two years commencing on the date above, and will automatically renew for successive one-year periods unless either party gives written notice to the other to terminate the Agreement effective at the end of the then-current period.
6. So long as Customer honors the exclusive arrangement referred to above and performs its obligations under this Agreement, Customer will not be charged for the Service. If Customer breaches its obligations hereunder, Blue Sky Bio-Fuels reserves the right to terminate this Agreement.
